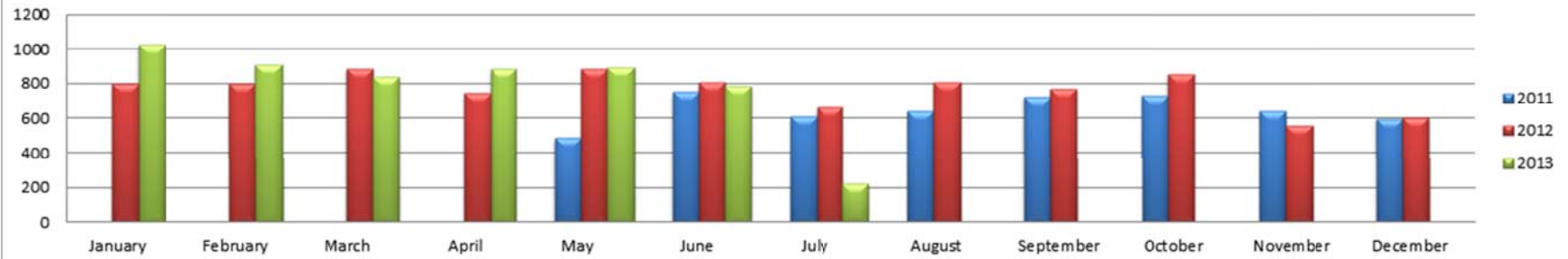

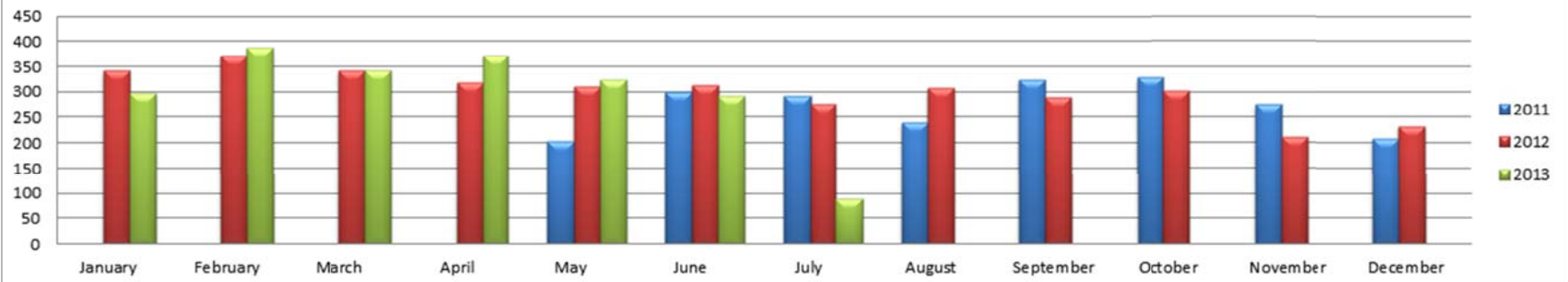


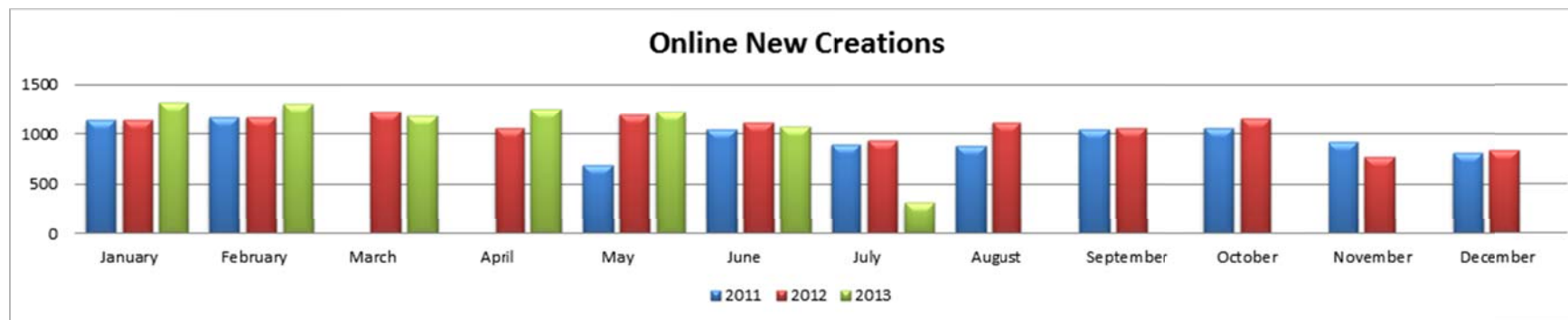


For Profits New Creations

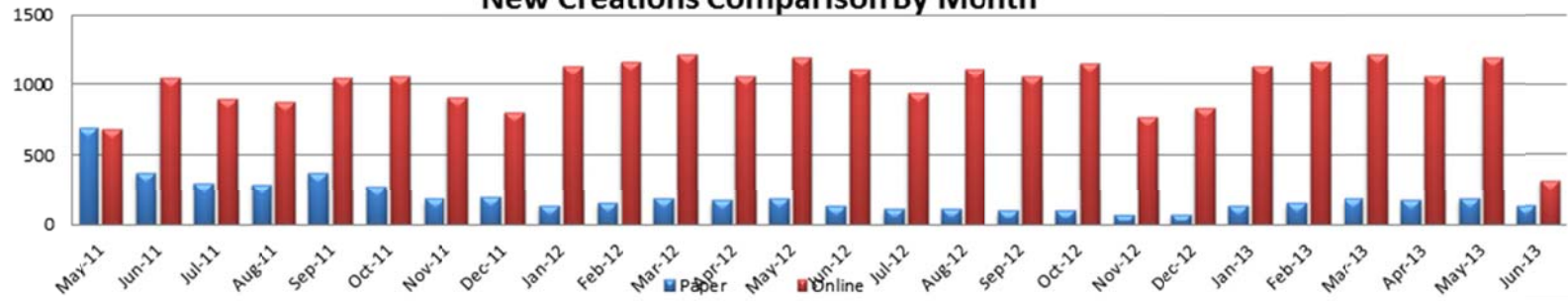


Non-Profits New Creations

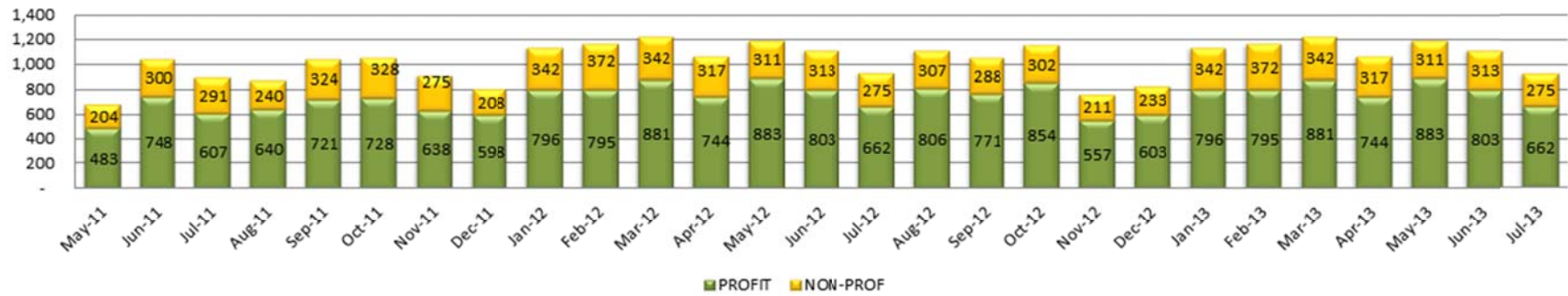




New Creations Comparison By Month
