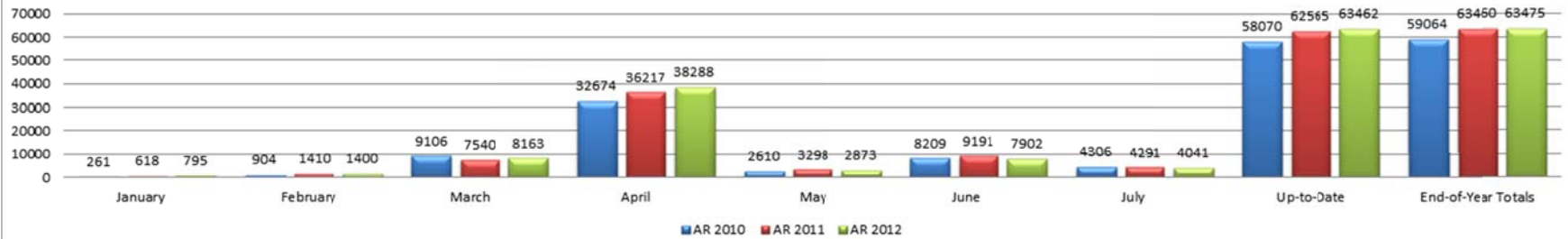

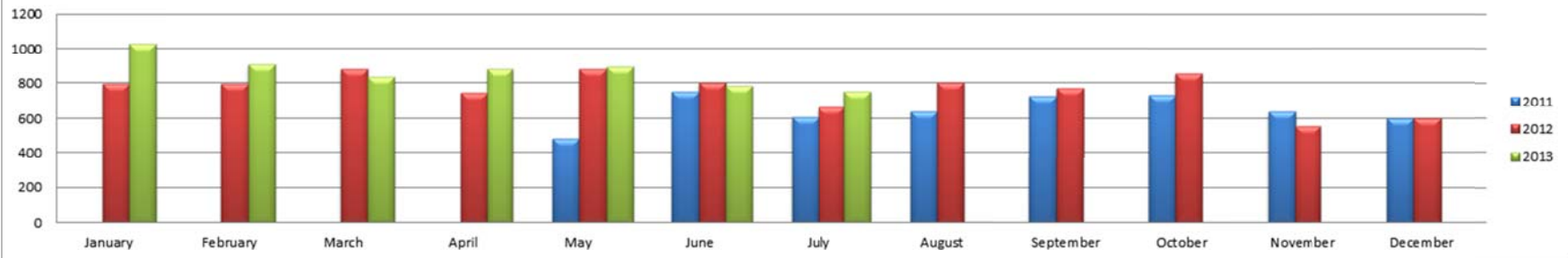

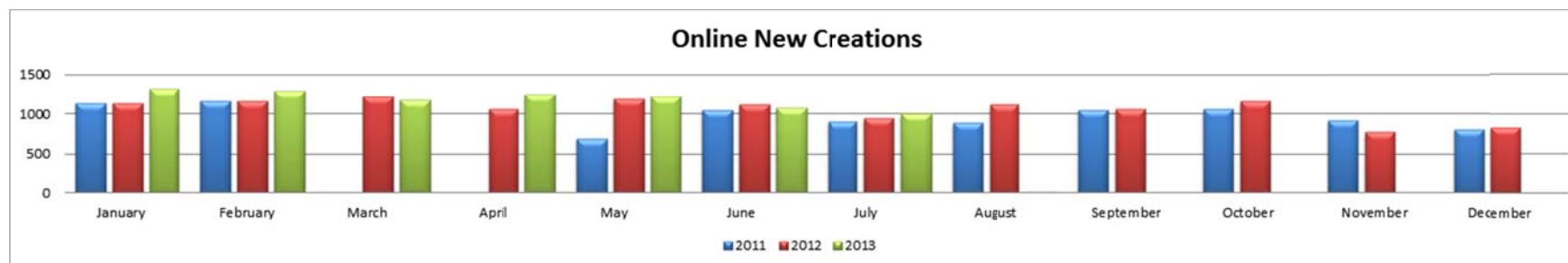
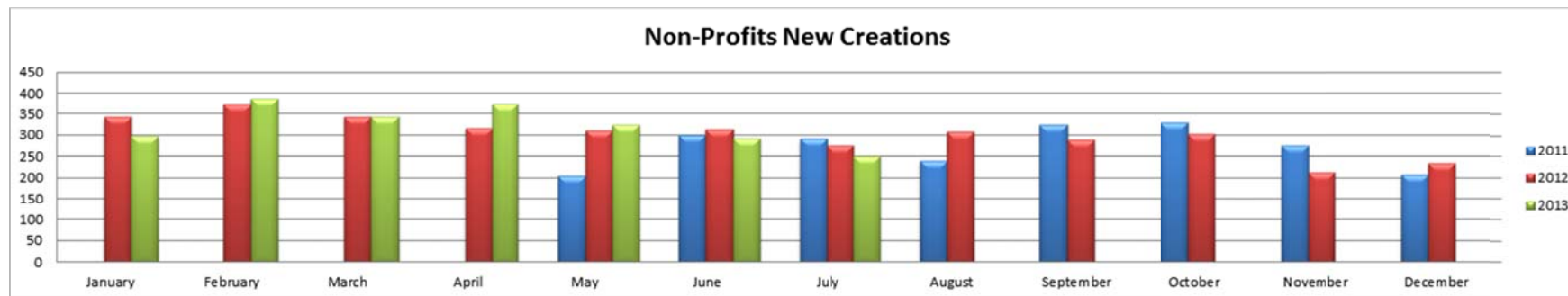


Good Standings - Multi-Years Comparison

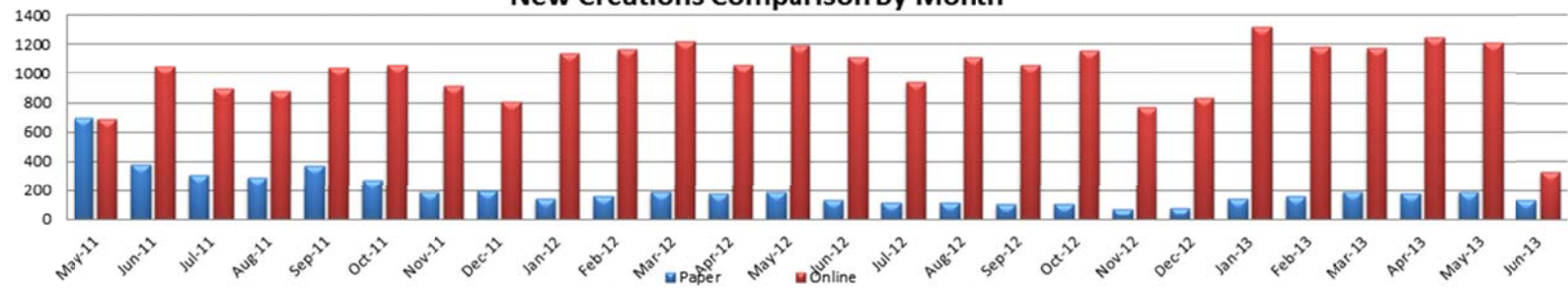

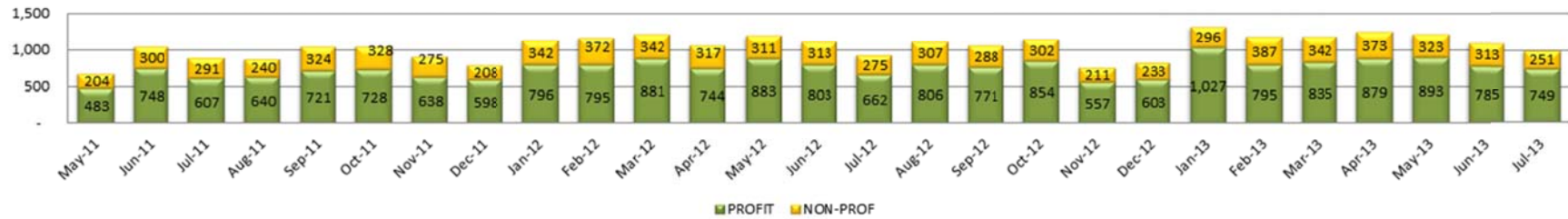




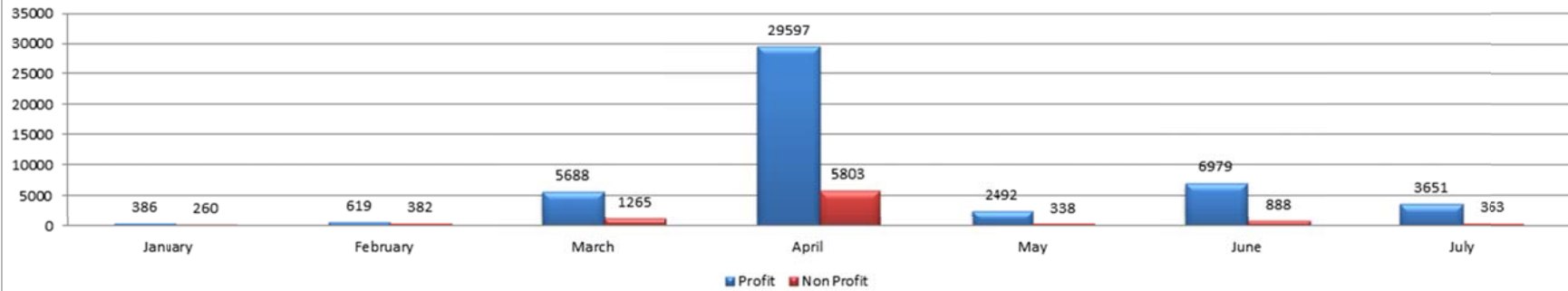
New Creations Comparison By Month



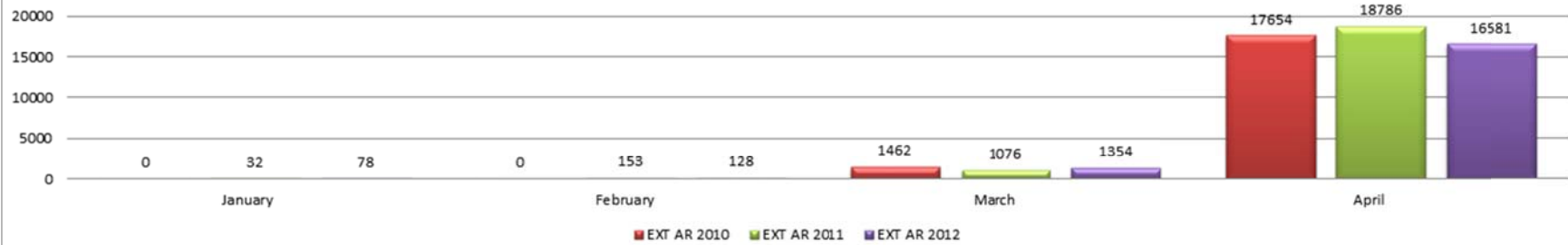
New Creations Online By Type



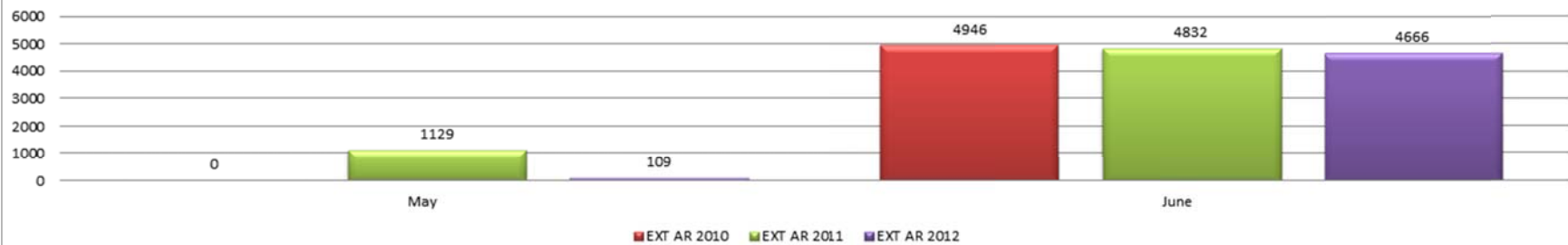
